ORDINANCE NO. 2014 - 01

AN ORDINANCE AMENDING ORDINANCE NO. 2011-06, WHICH ORDINANCE ESTABLISHED NEW WATER AND CAPITAL USER RATES AND CHARGES, IN ORDER TO INCREASE CERTAIN RATES FOR FISCAL YEAR 2014

WHEREAS, the Village currently operates a water system, and its sewer needs are now serviced by the Rock River Water Reclamation District pursuant to an Intergovermental Agreement previously signed; and

WHEREAS, the Village schedule of upgrades and construction related to waterworks and sewer connection to the Rock River Water Reclamation District changed from the original plan on which the rates set forth in Ordinance No. 2011-06 were calculated, such that for the fiscal year 2013, a slight decrease in certain rates was possible, and such decrease was deemed to be in the best interests of the citizenry of the Village of Winnebago; and

WHEREAS, for the fiscal year 2014, a slight increase in the rates is necessary in order to meet the needs of the village.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Winnebago, as follows:

SECTION I—AMENDMENTS
