ORDINANCE NO. 2010-4

**ORDINANCE ESTABLISHING SERVICE CHARGES
ON GARBAGE PICKUP RATES**

WHEREAS, the Village of Winnebago entered its latest contract with Gill's Freeport Disposal, Inc., on or about February 13, 2009, for garbage pickup services for the residents of the Village of Winnebago; and

WHEREAS, the contract is for a period of five (5) years covering the years of 2009 through 2013; and

WHEREAS, the contract provides for the fee to the Village for each household to be the following rates for the respective years listed:

2009--\$12.50

2010--\$12.88

2011--\$13.26

2012--\$13.66

2013--\$14.07; and

WHEREAS, 65 ILCS 5/11-19-4 provides in part pertinent that the corporate authorities of each city, village and incorporated town, whether organized under the general law or special charter, with a population of less than 500,000, may finance the establishment and maintenance of systems or plants, by contract or by direct provision, for the collection and disposal, treatment, or recycling or solely for the collection or solely for the disposal, treatment or recycling of garbage, refuse and ashes by service charges to be collected from persons, firms and corporations receiving service. Such service charges shall be established as can reasonably be expected to yield revenues not in excess of contract obligations and the costs of operation, maintenance, and

an adequate depreciation fund, provided charges so imposed shall be adopted by ordinance and a copy of the schedule of charges shall be furnished to each customer; and

WHEREAS, in order to recoup a portion of the administrative costs associated with generating and collecting garbage bills, the Village Board of Trustees feels it is reasonable and in the best interest of the Village of Winnebago to impose modest service charges onto the cost of the garbage billing, commencing with the bills generated in February, 2010.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Winnebago, as follows:

SECTION 1. Effective with the billing generated in February, 2010, by the Village of Winnebago for garbage collection, the rate charged to the residents shall be as listed hereinbelow, reflecting a slight increase annually to the amounts charged by the garbage hauler provider to the Village, as listed in the hauler rates listed hereinabove, which increased amounts shall reflect service charges by the Village for the administrative costs associated with generating and collecting garbage bills, and which service charges have been calculated to the next highest quarter increment of the actual charge to the Village:

2010--\$13.00 (service charges of \$0.12)

2011--\$13.50 (service charges of \$0.24)

2012--\$13.75 (service charges of \$0.09)

2013--\$14.25 (service charges of \$0.18)

SECTION 2. A schedule of the service charges shall be provided to each customer annually with the first bill sent out charging the increased rate, or, for new customers, when the first garbage collection bill is sent out. The schedule of service charges notification shall be in substantially the following form:

SECTION 3. This ordinance shall become effective immediately upon its passage, approval, and publication in pamphlet form
