

ORDINANCE NO. 2012 - 02

**AN ORDINANCE LEVYING TAXES FOR ALL CORPORATE  
PURPOSES FOR THE VILLAGE OF WINNEBAGO, ILLINOIS, FOR  
THE FISCAL YEAR BEGINNING JANUARY 1, 2012,  
AND ENDING DECEMBER 31, 2012**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Winnebago, Illinois:

Section 1: The amounts hereinafter set forth, or so much thereof as may be authorized by law, and the same are hereby levied upon all property subject to taxation within the municipality as that property is assessed and equalized for the current year, and for such purposes as: General Corporate, Police Protection, Chlorination, Liability Insurance, Audit, and Pension for the Village of Winnebago, Winnebago County, Illinois, for the fiscal year beginning January 1, 2012, and ending December 31, 2012.

Section 2: The amount levied for each object and purpose is listed as follows:

General Corporate	\$220,232.44
Police Protection	198,038.24
Chlorination	0
Liability Insurance	47.93
Audit	47.93
Pension	<u>47.93</u>
TOTAL	\$418,414.47

Section 3: The Village Clerk shall make and file with the County Clerk of Winnebago County, Illinois, on or before the last Tuesday in December, a duly certified copy of this ordinance, with the requirement this year being that the same be filed on or before Friday, December 21, 2012, because the last Tuesday in December of 2012, is December 25, 2012, and the Winnebago County Clerk's Office is closed on both Monday, December 24, 2012, and Tuesday, December 25, 2012.

Section 4: If any section, subdivision, or sentence of this ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.

Section 5: This ordinance shall be in full force and effect after its adoption, as provided by law.
