BE IT ORDAINED by the President and the Board of Trustees of the Village of Winnebago, Illinois:

Section 1.

It shall be unlawful for any person to shoot, throw, or propel by means of any air gun, slingshot or bow and arrow or other method or device, any ball, bullet or other missle or projectile in any place within the Village where any person or property is apt to be struck, or in any way injured thereby.

Section 2.

Any person found guilty of violating this Ordinance shall, upon conviction, be fined not less than twenty-five dollars (\$25.00) nor more than five hundred dollars (\$500.00) for each offense.

This ordinance shall be in full force and effect from $\underline{\int u v \mathcal{E} \mathcal{F} \mathcal{F} \mathcal{F}}$, the date of and after its passage, approval and publication, as provided by law.
