# RESOLUTION ADOPTING UTILITY TERRAIN VEHICLE (UTV) APPLICATION AND UNCONDITIONAL INDEMNIFICATION AND WAIVER FORMS

WHEREAS, the Village of Winnebago, via a related ordinance, is in the process of adopting an ordinance permitting the operation of Utility Terrain (UTV) vehicles within certain areas of the Village of Winnebago; and

WHEREAS, such usage shall involve the issuance of a permit to the duly authorized registered owner of the UTV; and

WHEREAS, it is, thus, necessary to have an application form to ensure all necessary aspects of issuance of the permit are considered; and

WHEREAS, since the operation of a UTV could pose certain risks to the owner, operator, or others, it is also necessary for an unconditional indemnification, liability release, and covenant not to sue to be signed by all UTV owners and operators as a condition of being allowed the privilege to operate such UTV in the Village of Winnebago so as not to expose the Village to any liability;

NOW THERFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Winnebago, Illinois, as follows:

#### **SECTION I**

By passage and approval of this resolution, the Village of Winnebago hereby officially adopts the Village of Winnebago, Illinois Application for Annual Permit (for Utility Terrain Vehicles) a copy of which marked Exhibit "A" is attached hereto, incorporated herein, and made a part hereof, and the Village of Winnebago Unconditional Indemnification, Liability Release, and Covenant Not to Sue for

UTV Owners and Operators, a copy of which marked Exhibit "B" is attached hereto, incorporated herein, and made a part hereof,

#### **SECTION II**

The provisions and sections of this resolution shall be deemed severable, and the invalidity of any portion of this resolution shall not affect the validity of the remainder.

#### **SECTION III**

All orders, resolutions, or ordinances in conflict herewith are hereby repealed insofar as such conflict exists, and this resolution shall take effect immediately upon its passage, approval, and publication.

#### VILLAGE OF WINNEBAGO, ILLINOIS APPLICATION FOR ANNUAL PERMIT UTILITY TERRAIN VEHICLES

Pursuant to Ordinance No. 2023— of the Village of Winnebago, Illinois, certain Utility Terrain Vehicles (UTV) may be approved for use on specified streets, roadways, and alleys of the Village where the posted speed limit is 35 miles per hour or less. UTVs may not be used on any toll road, interstate highway, controlled access highway or other highway or road under the jurisdiction of the State of Illinois, County of Winnebago, or Winnebago Township unless written permission for the same has been secured by the Village of Winnebago as would be evidenced on the map provided by the Village with its ordinance to show the permitted areas of travel for UTVs. Utility Terrain Vehicles means:

A commercially designed and manufactured motorized off-highway device designed primarily for off-highway travel, 64 inches or less in width, having a manufacturer's dry weight of 2,000 pounds or less for gas-powered engines or 3,000 pounds or less for electric-powered engines, traveling on 4 or more non-highway tires, a steering wheel for steering control, and designed with non-straddle seating that confirm to applicable federal regulations (see Title 49 C.F.R. part 571.500). UTV shall not include equipment such as lawnmowers.

Applicants shall be required to comply in all respects with Ordinance \* of the Village of Winnebago and the Illinois Motor Vehicle Code, including the obligation to purchase an annual permit from the Village. Violations may result in suspension or revocation of the permit and significant fines and other penalties.

# PLEASE READ CAREFULLY BEFORE SIGNING AS THIS IS A LEGALLY BINDING DOCUMENT.

In consideration of the granting of my application as on Owner/Operation for a Utility Terrain Vehicle (UTV) operating permit with the Village of Winnebago, IL, (hereinafter sometimes referred to as "Village") I hereby, by my signature hereunder, agree to the following:

- 1. I fully recognize that there are dangers and risks to which I may be exposed by operating a Utility Terrain Vehicle (UTV) on allowed Village Streets. The following is a description and/or examples of significant dangers and risks associated with the activity: injury to myself of others, damage to my property or the property of others, death of myself or others.
- 2. In no event shall the Village be liable for direct, indirect, special, incidental, or consequential damages, whether arising in tort, contract, or any other legal theory, in connection with or arising out of owner/operator's use of the UTV on allowed Village streets.

The Owner/Operator, as of the date below shall hereinafter, save, hold harmless, and indemnify the Village against any and all liability, claims, causes of action, and costs of whatsoever kind and nature, including, without being limited to, injury, damage, loss, including death, resulting from, arising out of, or occurring in connection with my use of a Utility Terrain Vehicle (UTV) on allowed Village streets.
- 4. I understand that the Village of Winnebago has an ordinance governing the use of qualified UTVs on allowed Village streets entitled "UTV Operation and Safety Ordinance", and I hereby agree to conform to, and abide by, all requirements of the Village ordinance at all times. I have received a copy of said ordinance, and have had the opportunity to read said ordinance, and I shall comply with said ordinances and the rules and regulations as cited therein, as well as all of the applicable traffic laws of the State of Illinois at all times when operating the UTV on allowed streets within the Village of Winnebago.
