**ORDINANCE NO. 2023- 13**

**ORDINANCE AUTHORIZING SALE OF SURPLUS PERSONAL PROPERTY  
(PUBLIC WORKS DEPARTMENT GENERATOR)**

**WHEREAS**, the Village of Winnebago, Illinois, previously purchased one (1) Multiquip Whisper Watt Diesel powered portable/trailer mounted AC Generator Model DCA 45 SSIUII, with Serial Number 7201328, including the AC Generator Model #DB-05011 with an ISUZI 4 CYCLE, 4.3 L Diesel Engine Model ISUZU B-4BG1, with a a 26.4 gallon fuel tank, with rating of 240/480 voltage, 3 phase and single phase, and rated output of 45kVA (kilo-volt-amperes) or 26 kilowatts, to service the Village's Sewage lift station; and

**WHEREAS**, per an Intergovernmental Agreement with Four Rivers Sanitation Authority, f/k/a Rock River Reclamation District, which entity took over the Village of Winnebago sewer system operations several years ago, Four Rivers Sanitation Authority has been using said generator for the above purpose; and

**WHEREAS**, Four Rivers Sanitation Authority is upgrading the site where the generator is used to install a permanent generator, but desires to keep the aforesaid generator unit for servicing other sites as needed; and

**WHEREAS**, the unit is too small to service the Village's water system, and was going to be used for the village's office building when returned to the Village by the District, but the Village in the interim has purchased another unit for the Village office, so the Village no longer needs the above generator; and

**WHEREAS**, pursuant to Chapter 65 of the Illinois Compiled Statutes, Section 5/11-76-4, whenever a city or village incorporated under any general or special law, other than a city or village of 500,000 or more population, owns any personal property which in the opinion of a simple majority of the corporate authorities then holding office, is no longer necessary for operations, or useful to the city or village, such a majority of the corporate authorities then


holding office, at any regular meeting or at any special meeting called for that purpose, by ordinance may authorize the sale of that personal property in such manner as they may designate, with or without advertising the sale; and

**WHEREAS,** since the Village is otherwise meeting its own generator needs, retention of ownership of the Multi-Quip Whisper Watt Diesel powered generator described above is no longer necessary or useful to Village operations, and, thus, it is not in the best interest of its citizenry to retain the same.

**NOW THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Winnebago, Illinois, as follows:

The Village Public Works Department, through, and in conjunction with, the Village Clerk, shall be and hereby is authorized to sell the Multiquip Whisper Watt Diesel powered portable/trailer mounted AC Generator, as more fully described above, to the Four Rivers Sanitation Authority for \$12,500.00 cash, with such generator to be sold in its "AS IS" condition with no express or implied warranties whatsoever.
