

ORDINANCE NO. 09-06

**AN ORDINANCE LEVYING TAXES FOR ALL CORPORATE PURPOSES FOR THE VILLAGE OF WINNEBAGO, ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 2009, AND ENDING APRIL 30, 2010**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Winnebago, Illinois:

Section 1: The amounts hereinafter set forth, or so much thereof as may be authorized by law, and the same are hereby levied upon all property subject to taxation within the municipality as that property is assessed and equalized for the current year, and for such purposes as: General Corporate, Police Protection, General Obligation (G.O.) Bond, Environmental Protection Agency (EPA) loan, Chlorination, Liability Insurance, Audit, and Pension for the Village of Winnebago, Winnebago County, Illinois, for the fiscal year beginning May 1, 2009, and ending April 30, 2010.

Section 2: The amount levied for each object and purpose is listed as follows:

General Corporate	\$ 248,095.03
Police Protection	148,009.53
Chlorination	50.00
Liability Insurance	50.00
Audit	50.00
Pension	<u>50.00</u>
TOTAL	\$396,304.56

In addition to the above amount, the General Obligation (G.O.) bond amount to be levied is \$88,267.78 since this is the last year of the 1990 General Obligation (G. O.) bond levy.

Section 3: The Village Clerk shall make and file with the County Clerk of Winnebago County, Illinois, on or before the last Tuesday in December, a duly certified copy of this ordinance.

Section 4: If any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.

Section 5: This ordinance shall be in full force and effect after its adoption, as provided by law.
