**ORDINANCE NO. 2021-*02***

**ORDINANCE ESTABLISHING SERVICE CHARGES**  
**ON GARBAGE PICKUP RATES**  
**2021 THROUGH 2027**

**WHEREAS**, the Village of Winnebago entered its latest contract with Gill's Freeport Disposal, Inc., on or about January 11, 2021, for garbage pickup services for the residents of the Village of Winnebago; and

**WHEREAS**, the contract is for a period of seven (7) years covering the calendar years of 2021 through 2027; and

**WHEREAS**, the contract provides for the fee to the Village for each household to be the following rates:

- \$15.50 a month for each one-family or two-family residence for weekly Services collection for January 1<sup>st</sup>, 2021 through December 31<sup>st</sup>, 2021 (the "Monthly Service Fee")
- \$14.75 for each one-family or two-family residence for weekly Services collection for January 1<sup>st</sup>, 2021 through December 31<sup>st</sup>, 2021 (the "Senior Citizen Service Fee") for households qualifying for the Senior Citizen Exemption on their property taxes as defined by Winnebago County or providing sufficient photo identification to the Village showing the resident is sixty-five (65) years of age or older
- Beginning on January 1<sup>st</sup>, 2022, and thereafter annually on January 1<sup>st</sup> for each year of the Agreement, the Monthly Service Fee and the Senior Citizen Service fee shall be increased in accordance with the CPI-U index (Garbage and Trash Collection Services, CUSR0000SEHG02). On each annual anniversary date the rates for Monthly Service Fee and the Senior Citizen Service Fee shall be adjusted to reflect changes in the cost of operations, as reflected by percentage change, during the immediately preceding twelve

(12) month period, in the Consumer Price Index (“CPI”) for All Urban Consumers, Garbage and Trash Collection, in U.S. City Average, Not Seasonally Adjusted, 1983=100, as published by the United States Department of Labor, Bureau of Labor Statistics (“BLS”), or its successor, with a floor of 2% and a cap of 4%” ; and

**WHEREAS**, 65 ILCS 5/11-19-4 provides in pertinent part that the corporate authorities of each city, village and incorporated town, whether organized under the general law or special charter, with a population of less than 500,000, may finance the establishment and maintenance of systems or plants, by contract or by direct provision, for the collection and disposal, treatment, or recycling, or solely for the collection, or solely for the disposal, treatment, or recycling of garbage, refuse, and ashes by service charges to be collected from persons, firms, and corporations receiving service. Such service charges shall be established as can reasonably be expected to yield revenues not in excess of contract obligations and the costs of operation, maintenance, and an adequate depreciation fund, provided charges so imposed shall be adopted by ordinance and a copy of the schedule of charges shall be furnished to each customer; and

**WHEREAS**, in order to recoup a portion of the administrative costs associated with generating and collecting garbage bills, the Village Board of Trustees feels it is reasonable and in the best interest of the Village of Winnebago to impose modest service charges onto the cost of the garbage billing, and voted in favor of the same at its February 8, 2021 General Board Meeting, with the terms to be memorialized in an ordinance.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Winnebago, as follows:

**SECTION 1.** Effective with the billing generated in March, 2021, by the Village of Winnebago for garbage collection, the rate charged to the Regular Residential Customers, and those charged to Senior Citizen Residential Customers as defined in the aforesaid agreement

between the Village of Winnebago and Gill's Freeport Disposal, Inc., shall be as listed hereinbelow, reflecting a slight increase annually to the amounts charged by the garbage hauler provider to the Village, as listed in the hauler rates listed hereinabove, which increased amounts shall reflect service charges by the Village for the administrative costs associated with generating and collecting garbage bills, and which service charges have been, or will be, calculated to the next highest quarter increment of the actual charge to the Village:

2021	\$15.75	\$14.85

For calendar year 2022, and each of the subsequent calendar years of 2023, 2024, 2025, 2026, and 2027, the rate charged to the Regular Residential Customers, and those charged to Senior Citizen Residential Customers shall be as defined in the aforesaid agreement between the Village of Winnebago and Gill's Freeport Disposal, Inc. Specifically, beginning on January 1<sup>st</sup>, 2022, and thereafter annually on January 1<sup>st</sup> for each year of the Agreement, the Monthly Service Fee and the Senior Citizen Service fee shall be increased in accordance with the CPI-U index (Garbage and Trash Collection Services, CUSR0000SEHG02). On each annual anniversary date the rates for Monthly Service Fee and the Senior Citizen Service Fee shall be adjusted to reflect changes in the cost of operations, as reflected by percentage change, during the immediately preceding twelve (12) month period, in the Consumer Price Index ("CPI") for All Urban Consumers, Garbage and Trash Collection, in U.S. City Average, Not Seasonally Adjusted, 1983=100, as published by the United States Department of Labor, Bureau of Labor Statistics ("BLS"), or its successor, with a floor of 2% and a cap of 4%".

**SECTION 2.** A schedule of the service charges shall be provided to each customer annually with the first bill sent out charging the increased rate, or, for new customers, when the

first garbage collection bill is sent out. The schedule of service charges notification shall be in substantially the following form:

For calendar year 2022, and each of the subsequent calendar years of 2023, 2024, 2025, 2026, and 2027, once the annual rate is calculated for Regular Residential Customers according to the formula referenced in Section 1 hereinabove for each of the calendar years 2022 through 2027, the annual service charge of \$.25 for Regular Residential Customers shall be added to the same, as calculated each year, with a notice in substantially the same form as listed hereinabove for 2021 provided to each customer with the first bill sent out charging the increased rate, or, for new customers, when the first garbage collection bill is sent out.



For calendar year 2022, and each of the subsequent calendar years of 2023, 2024, 2025, 2026, and 2027, once the annual rate is calculated for Senior Residential Customers according to the formula referenced in Section 1 hereinabove for each of the calendar years 2022 through 2027, the annual service charge of \$.10 for Senior Residential Customers shall be added to the same, as calculated each year, with a notice in substantially the same form as listed hereinabove for 2021 provided to each customer with the first bill sent out charging the increased rate, or, for new customers, when the first garbage collection bill is sent out.

**SECTION 3.** This ordinance shall become effective immediately upon its passage, approval, and publication in pamphlet form
