RESOLUTION AFFIRMING THE PURCHASE OF A 2022 FORD
EXPLORER POLICE INTERCEPTOR VEHICLE

WHEREAS, The Village of Winnebago operates a police department for the safety of the community;

WHEREAS, during the course of operating the police department, vehicles have been purchased to support the police department in its daily operations;

WHEREAS, a 2017 Ford Explorer Police Interceptor vehicle which had been in service with the police department was involved in a single vehicle crash on 03/12/2022, rendering the vehicle a total loss;

WHEREAS, the purchase of a new 2022 Ford Explorer Police Interceptor vehicle from Jim Hayes Inc. to replace the total loss of the 2017 Ford Explorer Police Interceptor vehicle has been made for the total cost of \$39,500.00;

WHEREAS, after much searching, a 2022 Ford Police Interceptor vehicle was located in Harrisburg, IL, and due to extremely limited inventory for vehicles, it was determined that immediate purchase was advisable, and an oral board member consensus was in favor of immediate purchase; and

WHEREAS, any limited additional accessories for the new vehicle that are necessary after the transfer of useable accessory items from the 2013 Ford Taurus Police Interceptor vehicle will be addressed in a future resolution.

NOW, THEREFORE, BE IT RESOLVED by the President and the Board of Trustees of the Village of Winnebago, in the County of Winnebago, Illinois, as follows:

SECTION I

The recitals set forth above are incorporated herein and made a part hereof.


SECTION II

The Village Board of Trustees hereby approves and affirms the prior actions of the Village Chief of Police in purchasing a new 2022 Ford Explorer Police Interceptor vehicle from Jim Hayes Inc. for the full price of \$39,500.00 with the funds taken from the General Police Fund – Line Item: **01-43-831**
